Year In Review

NDRPA was actively engaged in the 2015 **State Legislative Session**, supporting funding for parks and recreation through the Outdoor Heritage Fund and Community Grant Program. The association also supported the Governor’s property tax levy consolidation for political subdivisions and worked successfully with other political subdivisions to oppose bills that negatively impacted park districts, such as additional notifications of property tax increases and changes to assessment projects. A member meeting was held in Bismarck in February in conjunction with **Parks Day at the Capitol**.

The **Certified Playground Safety Inspector Course** was held in Bismarck March 10-12 for the 13th year with 38 participants. The North Dakota Insurance Reserve Fund (NDIRF) and North Dakota Parks and Recreation Department (NDPRD) again served as sponsors. The **HR Collaborative** continued its efforts with NDRPA promoting four trainings across the state in July. NDRPA co-hosted the fourth annual **North Dakota Trails Conference** in August in Valley City. NDRPA held its annual **State Conference** with the theme “All In!” in Fargo on Sept. 29-Oct. 1.

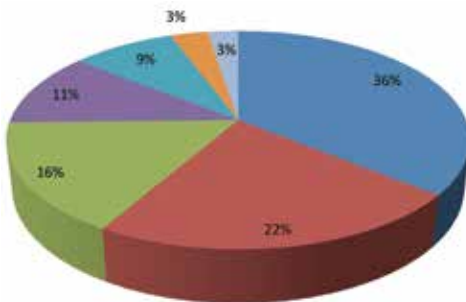

Financials

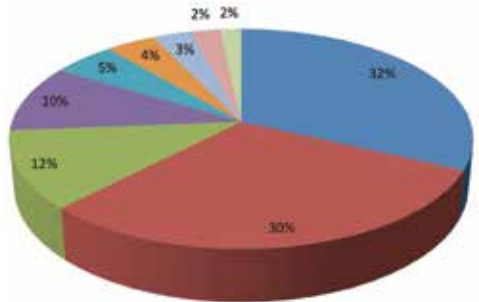
Due to a fiscal year change from October 1-September 1 to calendar year, this report reflects revenue and expenses from October 1, 2014, through December 31, 2015.
